Migration of the Zachariah BLACKLEDGE and Mary GRESSETT Family

 Zachariah BLACKLEDGE, born 28 Jul 1767 in Orangeburg District, South Carolina He married on 7 Jul 1787 in Orangeburg District, South Carolina Mary GRESSETT, born 18 Jan 1770 in Orangeburg District, South Carolina; died in Jones County, Mississippi, daughter of Colonel John GRESSETT and Susanna Elisabetha FUNCHESS.

Notes for Mary GRESSETT: Mary Gressett is a sister to William Gressett, son of John Gressett, the Rev. War soldier. Their four known children: William Gressett, b. 1765-70; his [supposed] sister Lydia Gressett, b. 1765-1770; Elizabeth Gressett, b. 1771 who married James Grimes; and a John Gressett, b. abt. 1774. Mary would fit well into the family of (Col.) John Gressett and his wife Susanna Elizabetha Fontius [Funchess]. Mary Blackledge named a daughter Lydia and also used the names John, Elizabeth, and William is the best circumstantial evidence available. Mary and Zachariah moved to Jones Co. MS approx. 1818/20 and her sister Lydia Byrd went with them because her husband abandoned her and her children. He went to GA. Zachariah (or at least a Zachariah Blackledge) appears on the 1790 Orangeburgh Census with a Lydia Gressett listed near him.

Migration of the Seaborn W. Buzbee and Rachel Sturkey Family

 Seaborn W. BUZBEE, was born about 1810 in South Carolina and died after 1860, possibly in Attala County, Mississippi. He married Rachel STURKEY before 1845 in South Carolina. Rachel was born about 1815-1825 in Orangeburgh, South Carolina, and died after 1853 probably in Mississippi. Seaborn and Rachel migrated to Attala County, Mississippi after the birth of daughter Heziah/Nancy in South Carolina about 1848/49.

Children of Seaborn BUZBEE and Rachel STURKEY are:

- a. William Jasper BUZBEE, born 09 Mar 1845 in Orangeburgh District, South Carolina; died 26 May 1932 in St. Francis County, Arkansas. William Jasper is on the 1880 census for Beat 3, District 156, Panola, Mississippi, with his wife and 7 children.

- 1. Isaac CARTER He married abt. 1780 in Orangeburg District, South Carolina Ann Elizabeth YOUNG, born in Orangeburg District, South Carolina, daughter of Henry YOUNG (SR) and Ann HILL.
 - Notes for Isaac CARTER: Isaac and Nancy (Young) Carter moved (with most of their children) west to MS and LA in the spring of 1810. The 1800 Orangeburg census shows them living in the area bound by the Fork of the Edisto, Beaver Creek and Four Holes. They are also on the 1790 census. Thomas Young who lived near them is thought to be Nancy's brother (also on the 1790 census).

- d. Mary CARTER, born 18 Mar 1792 in Orangeburg District, South Carolina; died 3 Jun 1861 in St. Helena Parish, Louisiana. She married in 1808 in Orangeburg District, South Carolina John Britton ADDISON, born 8 May 1781; died 10 Dec 1829 in St. Helena Parish, Louisiana.
- e. Burrell CARTER, born 2 Jun 1796 in Orangeburg District, South Carolina; died 18 Aug 1860 in Louisiana. He married on 29 Oct 1818 Judith TAYLOR, born 3 Nov 1796; died 2 May 1883, daughter of Nimrod TAYLOR and Judith BANKSTON. Lived on Darlington's Plantation, Chipola, LA and he was buried on Darling's Creek.
- f. Derrell CARTER, born 20 Jan 1799 in Orangeburg District, South Carolina; died 1876 in Cotton Valley, Webster Parish, Louisiana. He married on 30 Jul 1818 Sarepta B. TAYLOR, born 1799 in Georgia; died 1876 in Louisiana, daughter of Nimrod TAYLOR and Judith BANKSTON.
- g. Harville CARTER, born 1805 in Orangeburg District, South Carolina; died 2 Nov 1865 in St. Cloud, Louisiana. He married Carolyn Virginia WHITE, born 19 Sep 1812; died 1 Aug 1897 in Jackson Parish, Louisiana, daughter of Robert WHITE and Judith TAYLOR.
- h. Israel CARTER, born 15 Dec 1807 in Orangeburg District, South Carolina; died 11 Jul 1878 in Sunny Hill, Louisiana. He married (1) Maria FELDER, born 1806 in Orangeburg District, South

- Carolina; (2) Elizabeth TURNER, born 5 May 1834; died 4 May 1916, daughter of Phillip TURNER and Mary ROBERTS.
- i. Elizabeth CARTER, born 1809 in Orangeburg District, South Carolina; died Nov 1864 in Louisiana. She married John HOUSTON.

Migration of the William Beverly CLAYTON and Mary GAVIN Family

 William Beverly CLAYTON, born 6 Oct 1777 in Orangeburgh, South Carolina; died 9 Mar 1841 in Noxubee, Green Co., Mississippi, son of William CLAYTON and Clayton [--]. He married on 20 Apr 1797 Mary GAVIN, born 5 Sep 1777 in Orangeburg District, South Carolina; died abt. 1820 in Green Co., Mississippi, daughter of Charles GAVIN and Bathiah BYRD.

Notes for William Beverly CLAYTON: When William and Mary Clayton and family arrived in Mississippi, they settled in Perry County about 2 miles up the river from the town of McLain. The family of John Lewis Dantzler which had arrived in Perry County, Mississippi in 1812, settled on the east side of the Leaf River. William Clayton's family settled on the west side of the river opposite John L. Dantzler's land. William Clayton bought this land in Dec. 1818.

Notes for Mary GAVIN: Migrated from Orangeburg, South Carolina to Mississippi before 1817. Drowned in the Leaf River near McLean, Mississippi.

- a. Isham Henry CLAYTON, born 26 Oct 1801 in Orangeburg District, South Carolina; died 13 Nov 1848 in Mobile, Alabama. He married Mary Elizabeth BOLTON, born abt. 1800; died 7 Nov 1881 in Jasper County, Mississippi. When Isham and Mary came from SC they settled in Greene County, Miss. until what is now Jasper County was purchased from the Indians, they then removed to Jasper County. He died of yellow fever in Mobile, Ala in 1847.
- b. John W. CLAYTON, born 13 Dec 1803 in Orangeburg District, South Carolina; died 1872. He married Mary Ann BERRY, died in Lauderdale County, Mississippi.
- c. Catherine B. CLAYTON, born 7 Feb 1806 in Orangeburg District, South Carolina.
- d. Charles Gavin CLAYTON, born 23 Dec 1808 in Orangeburg District, South Carolina; died 1 Sep 1857 in Lauderdale County, Mississippi. He married on 23 Mar 1830 in Perry County, Mississippi Avaline DANTZLER, born 25 Mar 1813 in Perry County, Mississippi; died 5 Apr 1889 in Perry County, Mississippi, daughter of John Lewis DANTZLER and Elizabeth HORGER.
- e. William Alexander CLAYTON, born 6 Feb 1811 in Orangeburg District, South Carolina; died 5 Jun 1867. He married (1) Sarah LOPER, died in Lauderdale County, Mississippi; (2) Nancy LOPER, died in Lauderdale County, Mississippi.
- f. Elizabeth McA. CLAYTON, born 9 Jul 1813 in Orangeburg District, South Carolina. She married abt. 1842 in Lauderdale County, Mississippi Thomas LEWIS, born abt. 1800 in North Carolina.
- g. Bertha Evaline CLAYTON, born 9 Jul 1813 in Orangeburg District, South Carolina; died 21 May 1875. She married Aaron A. BOLTON.
- h. Henry R.G. CLAYTON, born 20 Jan 1817 in Orangeburg District, South Carolina; died 1859 in Lauderdale County, Mississippi. Never married. Was insane from young manhood.
- i. Clarasa CLAYTON, born 27 Nov 1820 in McLain, Perry Co., Mississippi. She married James SYKES, died in Texas. Moved to Texas in 1849.

He married (1) abt. 1812 Delilah JOYNER, born abt. 1790 in Orangeburgh District, South Carolina, died 1816 in Orangeburgh District, South Carolina; (2) abt. 1825 Unknown.
 - Notes for Samuel Rowland COLLIER: Children of Samuel Rowland Collier and Delilah Joyner were:1e1. Elizabeth Jane COLLIER, born 9 Mar 1815 in Orangeburgh District, South Carolina,

died abt. 1853 in South Carolina, married William WHITSELL; 1e2. John Samuel COLLIER, born 18 Mar 1816 in Orangeburgh District, died 21 Apr 1871 in Belton, Bell County, Texas, married Eliza DUKES.

 John Samuel COLLIER, born 18 Mar 1816 in Colleton County, South Carolina, died 21 Apr 1871 in Belton, Bell County, Texas, son of Samuel Rowland COLLIER and Delilah JOYNER. He married (1) on 13 Sep 1838 in South Carolina Eliza Alphalet DUKES, born 16 Jul 1819 in Orangeburg District, South Carolina; died 24 Jan 1861 in Brandon, Rankin County, Mississippi, daughter of Thomas Edmund DUKES (JR) and Ann AYLAR; (2) on 17 Oct 1868 in Brandon, Rankin County, Mississippi Lucinda MCCULLOUGH, born abt. 1831 in Georgia, died aft. 1880 in Mississippi.

Notes for John Samuel COLLIER: John Samuel, wife Eliza and 5 children moved from OB SC to Fl in the winter on 1848/49. One child was born there in 1852. He then moved his family to Leake County MS in the winter of 1852/53 where 2 more children were born. In the winter of 1859/60 he moved his family to Rankin County, MS. Eliza died there in 1861. He married Lucienda McCullough in 1868 in Rankin County MS and with her fathered another child. In the winter of 1869/70 he moved to Belton, Bell, TX leaving Lucienda and his child with her in MS. He died in Belton, Bell, TX in 1871 and was buried there.

Notes for Eliza Alloy DUKES: Also known as Eliza Alphalet DUKES.

 - Notes for Peter FELDER (SR): 1759 On Sunday April 22 in Orangeb. Church. Peter, son of Henry and Mary Elizabeth Felder; born April 2, 1759. Suret: John and Barbara Giessendanner, Jacob Giessendanner. (Rev. Giessendanner). Moved to Mississippi in 1810-1811 Peter Felder, coming from Orangeburgh in 1810 divided his family. His son, John, and others came directly over land to then Amite County, Mississippi. Peter himself went to the Tennessee River and rafted to the Ohio, then down the Mississippi River to Natchez where John met him. John and his brothers brought the stock (mainly horses) overland, while his father and mother came by boat. After arriving in Mississippi in an area not too far from Magnolia in 1810, John left the stock near Magnolia and went on to Natchez where the old couple was to have landed. Upon his arrival, he was very distress as not finding his parents there; a delay caused by the slowness of the vessel on which they were passengers. After a week's delay, the boat arrived and the Felders enjoyed a

reunion. They traveled on to Magnolia and established a permanent homesite. Peter Felder first settled in Amite County, but lived his last years in Pike County. Peter Felder settled the Vaughn place, near Magnolia, in 1811. A Methodist Church was established in this neighborhood, and in 1810 the first Methodist camp meeting was held here. It was afterwards known as Felder's Campground.

A Methodist Church was established in this neighborhood, and in 1810 the first Methodist camp meeting was held there. It was afterwards known as Felder's Church. Peter was appointed by the Governor as one of the commissioners, under acts of 9 Dec 1815, to select, procure and fix the permanent seat of justice of Pike Co. In 1840 he settled on a farm in Topisaw and with Christian Hoover, Hardy Thompson, David Winborne, Matthew McEwen, Samuel Whitworth, Archie McEwen and Silas Catchings establishing the Topisaw Camp Grounds in 1843. In 1846 he had a water mill constructed over Topisaw, an upright saw, grist and cotton gin near the camp grounds. The migration to the Mississippi Territory in the early 1800's brought Peter Felder, the son of Henry Felder, from the Barnwell

District, SC. In 1811 he settled on what is known as the Vaughn place near Magnolia. About 1780 he married Elizabeth Lowe. Peter Felder soon assisted in establishing a church in this community known as Felder's Church. He was one of the commissioners appointed by the government under acts of December 9, 1815 to select, procure, and fix a permanent seat of justice of the Orphan's Court which had jurisdiction in probate matters. Peter Felder's sons were Charles, who became a physician and moved to Amite Co.; Peter Jr. a farmer of much wealth; Isaac who never married but devoted his time principally to agricultural pursuits; Daniel who moved to Texas and John. The daughters were Mrs. Nancy Winborne, Mrs. James Sibley who moved to Texas, Mrs. Mary Dickerson, Mrs. Maria Carter, and Mrs. Kessiah Rawls. John Felder then, son of Peter Felder, is the ancestor of the Felder's of Pike Co. He was born in Barnwell District, SC in 1793, moving with his father to Mississippi in 1811. In 1812 he married Miss Elizabeth Sandell. Twenty years later John Felder and his wife settled on the beautiful little stream Topisaw, nine miles from MaComb. He and other people living nearby, assembled in a beautiful grove to hold religious services. Later a church was built and now called Felder Methodist Church. The land was given by John Felder to build the church and tabernacle. His picture hangs in the church there. John and Elizabeth Felder were parents of Mary Catherine, born 23 Sep 1813 who married Seaborn Alford; Elizabeth born 2 Feb 1818, married Tom McEwen; Wyatt Westley born 15 May 1815, married Cynthia Hope; Gabriel Nolly born 25 Mar 1820, married Fanny Hodges; Robert Henry born 9 Oct 1824, married Elizabeth Thompson; Levi Darius born 22 Sep 1822, married Martha Williams; Simeon Noble born 23 Feb 1827, married Mrs. Mary Buie; Minerva Felder born 6 Jun 1828, died 1924, married Monroe McEwen. John Felder died in 1876, and was buried near the Camp Ground in the family cemetery. The funeral services were conducted by Dr. H.L. Johnson, President of Whitworth College, who paid a touching tribute to his life. A copy of this eulogy was published in the local paper and was also placed in the corner stone of the old courthouse in Pike Co. When that building was razed a number of years ago, the paper was removed and sent to a member of the family. It is now in the possession of the Felders who prize it very highly. Saturday, November 27, 1943 issue of the McComb, Mississippi Daily Enterprise. Charles Felder, son of Peter Felder, Sr., became a physician and moved to Amite Co. He married Miss Sarah Lea who died January 31, 1843. Charles Felder died 15 May 1843. He was a pioneer preacher in Mississippi and Louisiana and was an active co-laborer with Cooper, Reeves, Courtney and others in South Mississippi; was often moderator of the Mississippi Association. The abstract history of the Mississippi Baptist Assoc. has this to say about Charles Felder: The Association committee selected to prepare a suitable obituary for the minutes, was composed of Elders J.B. Smith, Ezra Courtney and Thomas M. Bond. In their report they say: "It has pleased an all-wise Providence to remove, since our last meeting, our beloved brother and moderator, C. Felder, who was in the 60th year of his age, and who has been thirty-four years a preacher, twentyfour of that time he has lived in this association. He was a sound consistent and able minister of the New Testament. As a pastor he has been surpassed by none in our country, as an

evangelist and revivalist, few exceeded him. His Christian deportment and soundness in the faith, connected with his indefatigable labors for the extension of the Redeemer's Kingdom, his making and preserving peace in the denomination, with all men, have embalmed his memory with undying esteem." A Quote says: In life they were lovely and pleasant, and in their death they were not long divided." They made their home in the East Fork (MS) community and are buried there. Charles and Sarah Lea Felder had nine children. James W. who married Maria Marsalis; Charles F.; William Riley; Rebecca, who married Thomas M. Bond; Nancy Ann, who married Thomas Everett; Sarah, who married Francis Wigley; Malinda who married Henry Barron; Eleanor, who married James Brabham, and Elizabeth, who married John Everett. Of their children, Charles F. and William Riley were physicians. Charles F. Felder married four times. His first wife was Ann O'Neal whom he married in Jan. 1838, and whom he had three children C.C., A.G., and D.C. Felder. His second wife was Mrs. Mary Ann Garner Raborn, widow of George Raborn and mother of two children, and widow of John Sibley by whom she had a daughter. Charles F. Felder's third wife was Malissa Jane Lea, by whom he had one child, A.D. Felder. The fourth wife was Mrs. Lenora J. Frith Bates. Charles Felder died in 1875 on his way to Texas. Lenora came back to Amite Co. and is buried there. Dr. Felder and his wife, Ann O'Neal, had three children – Christopher Columbus, A. G. Felder, and D.C. Felder. Columbus as he was called, married in 1860, Talitha Varnado, daughter of Isham and Margaret Hope Varnado. Albert G. Felder, a Baptist minister, married Louisa Williams on 8 Feb 1866. They were the parents of nine children. Dewitt C. Felder married on 28 Oct 1868 to Miss A.E. Bates (full name unknown). Dr. Felder and his second wife had no children. Mary Ann Raborn Sibley had three children by her two previous marriages, and Dr. Felder had three. By his marriage to Malissa Jane Lea he had another son, A.D. Felder, who was born 27 Jul 1861. He became a physician, having graduated from Louisville Medical College in Louisville, KY in the spring of 1885. In Nov of 1886 he married Miss Ada Lenore. They moved from Amite Co. to Magnolia, MS in Jan of 1890, where he built up a large and lucrative practice. (See page 278, Vol I, Biographical and Historical Memoirs of Mississippi) Dr. Felder's fourth and last marriage, to Lenora Bates, produced no children. In an effort to improve his health, it was his intention to move to a drier climate. They set out for Texas but never reached their destination. After his death, she returned to Amite Co. and died there. Christopher Columbus Felder, born 20 Aug 1840, died 20 Nov 1924 at the age of 84, married in 1860, Talitha Angeline Varnado. She was born 3 Oct 1840 and died 24 Apr 1897. Both of them are buried in the Varnado Cemetery in Osyka, MS. His grave has a marker with the following inscription: Felder, C.C., Corp. Co.B, 33rd Miss. Inf. CSA. There are no dates on the stone. Talitha died 27 years before her husband. In his later years he went to live with his son, Robert H. (Bob) Felder in East Fork Community near Kentwood, LA. Their Children were: Annie P. who married William Benjamine Franklin Lewis (Billy) on 23 Dec 1879; Monroe Felder who married Maggie Emma Dykes on 23 Dec 1889; Margaret H. (Mag) Felder who married George A. Dickey on 16 Jan 1899; Arie Quinnie Felder who married George Felix Dykes on 23 Dec 1889; Robert H. Felder who married Sareptha

Cutrer on 15 Jan 1902; Alice H. Felder who married Joseph A. Bennet on 16 Jan 1899; James (Jimmy) Felder who died young and Esther E. who also died young. Annie and Billy Lewis had Hollis, Lennie, Grover C., Mamie and Katie Lewis. Only Grover and Katie grew to maturity. Notes for William GRESSETT: Witness to will of Thomas Gavin, of Colleton District 14 March 1811. Five land grants are recorded in the name of William Gressett or Grissett for land in Orangeburg District, all in the same area, first 7 April 1788 and the last 2 August 1819. No record shows the name of the first wife of William Gressett, but there are clues. An account by Major David Gavin of a visit to relatives in Mississippi refers to his cousin Charles Gressett of Lauderdale County (25 June 1843), and this relationship is confirmed by a reference in his diary: "My paternal grandfather Charles Gavin, paternal Aunt Gressett and other relatives are buried on Cattles Creek in Orange Parish. Cattle Creek was the location of the first land grant to William Gressett. A conclusion may be drawn that the wife of William Gressett was the sister of Major Gavin's father and thus the daughter of Charles and Bathiah (Byrd) Gavin, early settlers in the same area. Charles Gressett apparently bore the middle initial G., from Gavin, as did his nephew, a son of William, and that a daughter of Catherine (Gressett) Tatum, a sister of William Jr. and thus a daughter of William Sr., bore the name Catherine Gavin Tatum is evidence of this connection. The Gavin family is enumerated near that of Lydia and William Gressett in 1800 and 1810 as is that of Christopher Tatum in 1820. While Christopher Tatum, Bathyra for Fathiah Gavin, and William Gressett are enumerated on the same page of the 1830 census for Greene County, Miss.

He married (1) Cynthia [--]; (2) on 3 Apr 1865 in South Carolina Martha BUSH. He was in Greene County, Miss. by 1827, and with a woman of his own age and a male child under 5, census 1830. A resident of Jone Co., Miss by 9 June 1836, when he purchased 50 acres and on census 13 April 1837, with his wife and 4 males under 18, in 1841 had 8 whites in household. In 1840 a woman of this own age, a woman 80-90 [Bathiah Gavin?] He has been identified as Catherine's brother
- d. Susan Elizabeth GRESSETT, born abt. 1809 in Orangeburg District, South Carolina; died 1877. She married Vincent REEVES.
- e. Charles Gavin GRESSETT, born 1810 in Orangeburgh, South Carolina; died in Grimes County, Texas. He was in Perry County, Mississippi by 2 Nov 1835, tax lists of Jasper Co., 1837-39. In Lauderdale County, MS in 1840 (age 20-30) with 3 females, by 1850 in Newton Co., MS.

He married (1) [--] HOOK; (2) in 1808 in South Carolina Elizabeth ZEIGLER, born abt. 1795 in Orangeburg District, South Carolina; died 26 Oct 1846 in Holmes County, Mississippi, daughter of J. ZEIGLER and C. [--]. Christian Hoover must have deceased in 1815 while living on Sweetwater Creek. Elizabeth ZEIGLER with her four younger Hoover children and her new husband (Brittian Smith) she moved to Holmes Co., MS after 1820.
- c. Jerushia McCover HOOVER, born abt. 1785 in Swansea, Lexington Co., South Carolina; died 7 Jan 1818 in Swansea, Lexington Co., South Carolina. She married in 1805 in Orangeburg County, South Carolina Elijah JEFFCOAT, born 11 Mar 1782 in Lexington, South Carolina; died 23 Sep 1857 in Pike County, Alabama; buried in Campground Meth., Portsburg, Crenshaw Co., Alabama, son of Samuel JEFFCOAT and Zelphir [--]. Jerushia McCover HOOVER, a Creek Indian from the Wind Clan. This couple migrated to Alabama ca. 1846. [REF: "SC Indians Indian Traders and other ethnic connections beginning in 1670" by Theresa M. Hicks, 1998.] Enumeration of Indians a good example of this is the Hoover / Martin / Jeffcoat families of Lexington Co., SC. John Hoover (1750/60 1832) was enumerated as White. Elijah Jeffcoat was listed in 1800 as non-White. Jeffcoat's wife was John Hoover's daughter, Jerusha. The Martin family is sometimes listed as White and sometimes as non-White. John Hoover's second wife was the widow of John J. Martin. The issue is further complicated by the fact that some of the Hoover children also went by the name of Martin. Sometimes the status of the husband seems to change from White to non-White depending on the status of the wife. pg. 331.
- d. Charles HOOVER, born 20 May 1788 in South Carolina; died 19 Feb 1849 in Lawrence Co., Georgia. He married (1) [--] MILLER, died 1819; (2) bef. 1825 in Wilkinson County, Mississippi Margaret BROWN, born abt. 1790; died 1833, daughter of Joseph BROWN and Sarah [--]. Ms. Miller. Children 1) Joseph Samuel md 1st Nancy Merrit, 2nd Annda Davis; 2), Nancy Ann md. John Gertman and their children: Joseph, John, William, Crete "Babe" and Lottie; 3) Elizabeth md. Jackson Brown and their children, Zack, Mary, Cynthia and unknown female.

Migration of the John HORGER and Rachel SHULER Family

 John HORGER, born 28 Oct 1758 in Orangeburgh, South Carolina and died 13 Aug 1821 in Greene County, Mississippi. He was the son of Jacob HORGER (SR) and Lovisia SHAUMLOFFEL. John HORGER married Rachel SHULER, born abt. 1766 in Orangeburg District, South Carolina; died 29 October 1849 in Greene County, Mississippi having married for the second time in 1824 to Major Martin MOODY following the death of her first husband, John HORGER. She was the daughter of Georg Nickel SHULER and Rachel [unknown]. John and Rachel HORGER and their minor children removed to Mississippi abt. 1812 settling into that portion of Greene County, that would later become Perry County. He is found in the 1816 Mississippi State and Territorial Census of Greene County with a household of 4 and 20 enslaved persons. Land records and property sale evidence, suggests their older married daughters and their families, other siblings, and some nieces with their families later joined them where they are found in the 1820 U.S. Federal Census of Greene County.

Children of John HORGER and Rachel SHULER were as follows:

- a. Margaret HORGER, born 19 Apr 1785 in Orangeburg District, South Carolina; died 19 Jul 1853 in Noxubee, Mississippi. She married on 13 Jan 1803 in Orangeburg District, South Carolina to Charles GAVIN (JR), born 15 Jul 1775 in Spartanburg District, South Carolina; died 18 Mar 1824 in Cliftonville, Noxabee Co., Mississippi, son of Charles GAVIN and Bathiah BYRD. They had eleven known children together.
 - [Research Note A: Charles and Margaret Gavin moved from South Carolina to Mississippi about 1817. Records of Perry County, MS Vol. 1, 1820-1830 Tax Rolls show Margaret Gavin with 160 acres and 23 slaves in 1829. The 1830 Noxubee County Census shows Margaret was in Perry County; owned property in 1848. Noxubee Co., MS 1850 census shows Margarett 66 yrs, Allen 38 yrs, Gabriel 32 yrs, Alfred 30 yrs.]
- b. Mary HORGER, born in Orangeburg District, South Carolina, though she was known as "Polly." She married David REECE [REESE]. He was born in South Carolina where he and Polly HORGER were likely married. They came to Mississippi and first settled in Greene County as early as 1817. David REESE purchased more than 580 acres in that portion of what was to become Perry County in 1820 and raised a large family. As the Choctaw Indian Nation ceded their lands to the U.S. Government, David REESE purchased several tracts of land in the newly formed Oktibbeha County, Mississippi where the family eventually settled by 1836. David REESE and Polly HORGER had ten known children.
- c. Elizabeth HORGER, born 1792 in Orangeburg District, South Carolina; died 1869 likely in Greene County, Mississippi. She married John Lewis DANTZLER, born 15 Aug 1788 in Orangeburgh, South Carolina; died 17 Aug 1852 in Greene County, Mississippi, son of Hans Jacob DANTZLER and Elizabeth Barbara CARN. He and his family migrated to Greene/Perry County, Mississippi with John HORGER about 1812 and would co-purchase property in that portion of Greene County that would later become Perry. He purchased additional property and eventually settled in Greene County on east side of the Leaf River opposite land bought by William and Mary (Gavin) Clayton. John L. DANTZLER and Elizabeth HORGER had six children.
- d. Absalom HORGER, born in Orangeburg District, South Carolina; died in January 1868 in Harrison County, Mississippi. He married Elizabeth WHITHERSPOON on 14 Feb 1822 in Amite County,

Mississippi. She was born about 1807 in South Carolina. They had four known children together.

Absalom HORGER came to Mississippi with his parents, and by 1820 he was the head of their household in 1820 according to the Greene County U.S. Census. He later removed to Copiah County eventually settling in Holmes County, Mississippi where his raised his family. By the time of his death, he had retired to the coast in Harrison County, Mississippi.

e. Ann HORGER, born abt. 1800 in Orangeburg District, South Carolina; died 19 Oct 1863 in Washington Co., Texas. She married abt. 1819, likely in Greene County, Mississippi, to her first-cousin, Gabriel FELDER the son of Samuel FELDER and Ann HORGER the daughter of Jacob HORGER(SR) and Lovisia SCHAUMLÖFFEL. Gabriel Felder was born 29 Jan 1797 in Orangeburg District, South Carolina and died 10 Mar 1868 in Washington Co., Texas.

Gabriel Felder bought land in Mississippi and engaged in farming while also serving as a Justice of the Peace and Tax Commissioner, afterwards using the title of Judge. He purchased additional property using monies inherited from the Felder family of Orangeburg building a sizable plantation Mississippi in several counties in Adams, Amite, and Scott.

In early 1851, they removed to Texas acquiring a large tract of land near Chappell Hill in Washington County. By the time the Civil War started, Gabriel Felder was a wealthy plantation owner of the largest plantation in the county. Ann Horger Felder died in 1863 following the outbreak of the Civil War, possibly from yellow fever that had broken out on his plantation lands being used as a POW encampment during the war. They had two known children.

[Research Note B: Some compiled genealogies incorrectly state Gabriel Felder married Ann Wait. However, the genealogy letter Rev. Whetstone wrote in 1846 documenting the family members still living at that time, Ann was listed as a daughter to John Horger of Orangeburg & later Mississippi. She was named as "Ann Felder lives in Scott county Miss." Gabriel Felder was the head of household there at the time as the only prominent landowner providing the provenance of her connection to the Horger family of Orangeburg.]

f. Rachel HORGER married Thomas SIMPSON. She died bef. 1846. Nothing further about them is known with certainty.

Though many researchers record her as the daughter of John HORGER and Rachel SHULER, there are no definitive sources recording that fact. She was not listed in Jacob Whetstone's brief genealogy written in 1846 as being among the living children. The strongest evidence of her likely existence is her mother's obituary written in 1849 that states Mrs. Rachel Moody died at her residence on Leaf River, Greene County, Mississippi "in the 83d year of her age. She was a native of Orangeburgh dist., S. C., where she married Mr. John Horger; emigrated to Mississippi in 1812, and in 1821 her husband died" The notice goes on to state she remarried to Major Martin

Moody and she was the mother of six children of whom five survive her along with her second husband. Daughter Rachel Horger would fit the description of being the 6th child, who was deceased at the time, consistent with the Whetstone narrative.

[Research Note C: Many researchers mistake the Jacob HORGER, born 1788 in Orangeburg District, South Carolina as the son of John HORGER and Rachel SHULER. This is not accurate. He was the son of Jacob HORGER (JR.) and Margaret Isabelle INABNIT, and would remove to Leon County, Florida. More information about him can be found in the Spring & Summer 2025 OGSGS Newsletters Vol. 21, No. 3 & 4.]

 Andrew KAIGLER (SR), born 1730 in Eschelbach, Baden, Germany; died abt. 1810 in Williamson Co., Tennessee He married abt. 1750 in South Carolina Catherine CULPEPPER, born 1733; died abt. 1805 in Williamson Co., Tennessee.

Notes for Andrew KAIGLER (SR): Andrew Kaigler lived in Sandy Run, S. C. during the revolution, the records show that he was a Lt. in Col. Robert Goodwyn 's S.C. Regiment. Neither his entry nor date of separation therefrom is shown but his name appears on an undated pay account with the sum of 975 (pounds) opposite his name. He lived in Orangeburg during the Revolutionary War, but some years afterward he migrated to Georgia and later to Williamson County, Tenn. where he died about 1810.

Notes for Jacob KERSH: Jacob was drafted July 1812 in Orangeburgh District, SC to serve in the War of 1812. He was discharged in March 1815. The Kersh family, with several other families from the Shiloh Meeting in Orangeburg, originally headed for Texas around 1824 or 28 via wagon train. The story goes that an oxen-pulled wagon train was passing through MS on the way to AR and TX. They paused at a spring in what is now the little settlement of Shiloh, MS. During the pause a young girl, whose name has been lost, wandered away to play. Swinging upon a grapevine, she fell and broke her neck. Delayed by a day for a proper christian funeral, which the curious Choctaw Indians watched, several of the families decided that these gentle, wooded hills offered as good a place as any to start a new life. Some of the families pushed on. Among the families who stayed were Jacob and William Kersh whose father Andrew Kersh had immigrated to SC in the 18th century and had served an indentured servitude to pay his family's passage to SC. William Kersh was an enterprising blacksmith who figured that cow bells were hard to come by on the frontier so he had hammered out a barrel full before he left and sold them along the way.

Other families who remained were the Rhodes, Myers and Varners. they were joined later by the Colliers, Nobles, Traxiers and Martins (Albert E). The Rhodes family appears to be the most prolific of the families for Rhodes marriages dominate the early Rankin County marriage books. Shiloh Cemetery in Rankin Co, MS was founded in 1828.

(Muller) Sistrunk, lived in this house for some years after their marriage in 1881. It is possible that Casper Sistrunk, before he changed his name from Gasper, could have procured the 82-acre tract of land on Dec. 30, 1805, as he was 21 years of age at that time, and the tract adjoined his father's property not far from the homestead. However, it is certain that he did get 25-1/2 acres on Little Beaver Creek in Orangeburg District on June 24, 1824, and this adjoined land he already owned and which his father had owned before him. Casper Sistrunk died before the Civil War. He had at least 5 slaves born on his place, as recorded in his Family Bible, but it is not known how many he owned. The names of three adult females are found in the records of Limestone Methodist Church in 1842, which was called Kedron Meeting House at that time.
